Trustees Annual Report for the year ended 31 March 2023

Objectives and Activities

Friends of the Family Winchester is a small, independent, Winchester-based charity which for almost 30 years has been offering confidential support to local families, empowering them to overcome adversity and face their future with confidence.

We offer practical support and a safe and nurturing environment where children and their families can learn to help themselves and focus on building a healthy family life for the future, breaking cycles of behaviour for future generations.

We do this by offering three programmes:

The **Mums** and **Young** Children **Project** is a therapeutic support group for vulnerable women and their pre-school children. The group comes together weekly in a non-judgemental space lead by a psychotherapist, while their babies and toddlers are looked after by a Play Leader and volunteers.

The **5s to 13s Befriending Service** matches a focus child aged between 5 to 13 years old with a trained volunteer who meets them once a week for two hours at time. The child benefits from a positive role model and additional support, whilst our Befriending Manager supports the wider family, offering support and signposting them to other specialised agencies to help them overcome their challenges.

Our third programme offers **Support for Dads** by providing counselling and a peer support group called 'Dads Aloud' to help dads in their role as a parent. We also work in HMP Winchester, providing mentoring and counselling for dads ahead of their release from prison, aiding the transition back into family life.

Volunteers are integral to our work, and we are very grateful for their commitment and support – we could not continue our work without them. Volunteers are recruited and coordinated by paid employees, undertake training, and are invited to additional training and discussion groups to share experience and best practice.

Public Benefit

In setting its plans and priorities for areas of work, the trustees have had regard to the guidance of the Charity Commission on public statement of benefit.



Chairperson's Statement for the year ended 31 March 2023

The past year has been one of change following a return to a new normal from the Covid pandemic. Change can feel daunting and unsettling, but I am delighted that with the backing of the Board and support from the staff we have emerged as stronger, more cohesive, and resilient Charity. Our ethos and projects haven't changed, and as we enter our 30th year we are proud to continue to support children and families in the Winchester district.

What are the changes?

- The appointment of Jo Smith in April 2022 as the Operations Director. This is a new role and provides leadership and direction for the staff team and an important link to the Board.
- The appointment of Shelley Dodd as a counsellor providing 1:1 sessions for our service users.
- The appointment of Jane Hall as the Volunteer and Operations Coordinator.
- The appointment to the Board of four new Trustees; Rebecca Lockwood with the portfolio for communications: Graham Jacobs with the portfolio of business; Cathryn Perrin with the portfolio of grants and fundraising and Jane Bennett as the Quaker representative.
- We said goodbye and thank you to three long standing Trustees; Rosemary Wright, Clare Sheppard and Jonathan Flory.

As a small, local charity with no central funding we are grateful to our major donors and partners in the last year, particularly The Henry Smith Charity for their 3-year grant to fund the 5-13's Project, Winchester Rotary, The Mayor of Winchester Cllr Vivian Achwal, The O'Sullivan Family Trust, The George Cadbury Fund and to Rathbones. I would like to thank anyone and everyone who has donated money, time, and expertise this year to ensure that we continue to deliver the high level of service and support to as many families as we can.

The attached Impact Statement shows the number of families we have helped, the befriender hours given, the counselling hours provided and the volunteers we have worked with. Without the volunteers our Charity cannot function. The time and dedication they have given to every one of our service users is immeasurable, they have changed lives and shaped futures and for this we are very grateful.

In this, my last Chair's report, I am honoured to pass the baton to the incoming Chair Chris Bale. Friends of the Family is in a good place, with a cohesive staff team and a talented Board, and ready to face the challenges of the next 30 years.





Financial review

Financial performance during the year was satisfactory. Income grew by 58% to £118,226 (2021-2022: £74,734) and expenditure was 29% higher at £105,734 (2022-23: £81,576), producing a modest surplus of £12,492.

Grant income was again strong at £53,328 (2021-2022: £45,050), and we were delighted to secure a further three years' funding from The Henry Smith Charity for our 5s to 13s project. We also had success with other grant applications and are very grateful to all our funders, including National Lottery Awards for All, The Albert Hunt Trust, Beacon Lodge Charitable Trust and the Hampshire and Isle of Wight Community Foundation.

Donations at £47,130 (2021-2022: £27,908) showed a 68% increase, and we thank all our members and other individuals, local churches and family trusts who support our work so generously.

We received a major donation of £15,000 from Winchester Rotary Club, and a further £5,400 from being one of the Mayor of Winchester's chosen charities in 2021-22. A partnership with Rathbones, which included a carol service in Winchester Cathedral and a donation from the company's foundation, raised £6,105. Other fundraising events included £1,030 from our Christmas quiz and a further £2,872 from our Christmas appeal.

The increase in expenditure during the year was planned and reflected trustees' determination to restore our services post-Covid and to strengthen our staff team. Staff salaries were 15% higher at £76,818 (2022-23: £66,328) as we employed a part-time counsellor and a part-time Operations Manager. At year's end, our services were all back to full delivery after the pandemic, and a busy schedule of training and family workshops for families incurred additional costs.

We are extremely fortunate to enjoy the goodwill of Winchester Quaker Meeting which continues to gift an office and space for our activities within the Friends Meeting House. The Friends' support of the charity since its inception has been invaluable.

Reserves policy

The charity holds a Designated Reserve Fund to ensure that its services can continue in the event of an unexpected fall in income. The amount is reviewed annually and the current figure of £31,500 (2021-22 £25,000) represents three months' projected expenditure in 2023-24. Trustees aim to increase the reserve to four months' expenditure when finances allow.

Structure, governance, and management

Friends of the Family Winchester is a company limited by guarantee and a charity registered in England. It is governed by its Memorandum and Articles of Association. The trustees of the charity are also directors and members of the company.

Membership is open to individuals over the age of 16 and to organisations. Members may vote at general meetings and play a role in the charity's governance and in shaping its future.



Trustees undertook a governance refresh in July 2021 and decided to limit the trustee board to 11 members and new Articles were approved on 4th November 2021.

The board also decided that trustees should generally serve a maximum of two terms of three years each but that exceptions may be made if suitable replacement trustees have not yet been identified. At the end of this financial year, three trustees had served more than the recommended maximum term — Nicola Bryant, Karen Hazlitt, and Lucilla Ward — and all are due to retire at the Annual General Meeting in November 2023.

Trustee vacancies are advertised as part of an open recruitment process. New trustees receive induction and training to cover the activities and structure of the charity and their responsibilities as charity trustees and company directors.

The trustees, who are also directors of the charity for the purpose of the Companies Act, present their annual report and the financial statements for the year ended 31 March 2023. The trustees have adopted the Charities SORP (Statement of Recommended Practice) (FRS 102) effective 1 January 2015.

Constitution and Objects

The Board of trustees, which meets at least six times a year, is responsible for the administration of the charity. These meetings are supported by the following committees – Management Committee, Fundraising Committee and Service Delivery and Impact Committee. Trustees receive no remuneration.

The charity has six part time salaried staff and benefits from the services of unpaid volunteers.

Trustees' Responsibilities in relation to the Financial Statements

The directors are responsible for preparing the financial statements in accordance with applicable law and United Kingdom Generally Accepted Accounting Practice.

The Companies Act 2006 requires the directors to prepare financial statements for each financial year which give a true and fair view of the state of the company and of the profit and loss of the company for that period.

In preparing those financial statements the directors are required to:

- (i) Select suitable accounting policies and then apply them consistently.
- (ii) Make judgements and estimates that are reasonable and prudent.
- (iii) Prepare the financial statements on a going concern basis unless it is inappropriate to presume that the company will continue to operate.

The directors are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the company.

They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Small Company exemption

This report has been prepared in accordance with the provisions applicable to companies subject to the Small Companies regime.

1. Accounting policies

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year.

a) Basis of accounting

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) - (Charities SORP (FRS 102)), and the Companies Act 2006. Friends of the Family Winchester meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy notes.

b) Fund accounting

Unrestricted funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity.

Restricted funds are subject to restrictions on their expenditure imposed by the donor.

c) Income

Voluntary income, donations and grants are accounted for on an accrual's basis.

d) Expenditure

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered and is reported as part of the expenditure to which it relates.

Charitable activities comprises those costs incurred by the charity in the delivery of its activities for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

Support costs include those costs associated with meeting the constitutional and statutory requirements of the charity and include the independent examiner's fee and costs linked to the strategic management of the charity.

e) Fixed Assets

Fixed assets including furniture and equipment are capitalised and depreciated to write off the cost of the assets over their estimated useful lives. The annual depreciation rates and methods used are as follows:

Fixtures and fittings- 25% per annum on a straight-line basis, on original cost Computer equipment – 33.3% per annum on a straight-line basis, on original cost

2. Premises

The charity uses an office in the grounds of the Friends' Meeting House in Winchester under a licence agreement dated 17 August 2004. Under a further licence agreement of the same date the charity enjoys the use of the main Meeting House and Garden in furtherance of its project work. The licences provide for the charity to make a financial contribution, which is currently waived by the Friends. Both licences are subject to six months' notice by either party. It is estimated that the value in the period to the Charity of these facilities is in the region of £12,000.

The trustees are extremely grateful to the Winchester Friends Meeting for their continued hospitality and support.



3. Trustees Expenses

No expenses were paid to any of the trustees during the year, except to reimburse them for purchases or out-of-pocket expenses made on behalf of the charitable company.
